SUMMARY

OFFER PRICE

- The final Offer Price has been determined at HK\$4.19 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

NET PROCEEDS FROM THE GLOBAL OFFERING

- Based on the final Offer Price of HK\$4.19 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting fees and commissions and estimated expenses payable by the Company in connection with the Global Offering and assuming that the Over-allotment Option is not exercised, are estimated to be approximately HK\$245.2 million.
- If the Over-allotment Option is exercised in full, the Company will receive additional net proceeds of approximately HK\$42.7 million for 10,500,000 Shares to be issued upon the exercise of the Over-allotment Option. In the event that the Over-allotment Option is exercised in full or in part, the Company intends to adjust its intended use of the net proceeds on a pro rata basis.
- The Company intends to apply such net proceeds in accordance with the purposes as set out in the paragraph headed “Net Proceeds from the Global Offering” in this announcement.

APPLICATIONS AND INDICATIONS OF INTEREST RECEIVED

Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed. A total of 10,159 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and under the **White Form elPO** service (www.eipo.com.hk) for a total of 36,597,000 Hong Kong Offer Shares, representing approximately 5.23 times of the total number of 7,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the slight over-subscription in the Hong Kong Public Offering represents less than 15 times of the total number of Offer Shares initially available under the Hong Kong Public Offering, no reallocation procedure as disclosed in the paragraph headed “Structure of the Global Offering – The Hong Kong Public Offering – Reallocation” in the Prospectus has been applied and no International Offer Share has been reallocated from the International Offering to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 7,000,000 Offer Shares, representing 10% of the total number of Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option), and being allocated to 2,545 successful applicants under the Hong Kong Public Offering.

International Offering

- The Offer Shares initially offered under the International Offering have been slightly over-subscribed. A total number of 75,600,586 Shares have been subscribed under the International Offering, representing approximately 1.20 times of the total number of 63,000,000 Offer Shares initially available under the International Offering. The final number of Offer Shares under the International Offering is 63,000,000 Offer Shares, representing 90% of the total number of Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).
- There were a total of 111 places under the International Offering. A total of 94 places have been allotted three board lots of the Offer Shares or less, representing approximately 84.68% of the 111 places under the International Offering. These places have been allotted 208,000 Shares in total, representing approximately 0.33% of the 63,000,000 Offer Shares available under the International Offering (before exercise of the Over-allotment Option) and approximately 0.28% of the 73,500,000 Offer Shares available under the International Offering (assuming the Over-allotment Option is exercised in full). A total of 71 places have been allotted two board lots of the Offer Shares or less, representing approximately 63.96% of the 111 places under the International Offering. These places have been allotted 139,000 Shares in total, representing approximately 0.22% of the 63,000,000 Offer Shares available under the International Offering (before exercise of the Over-allotment Option) and approximately 0.19% of the 73,500,000 Offer Shares available under the International Offering (assuming the Over-allotment Option is exercised in full). A total of 3 places have been allotted one board lot of the Offer Shares, representing approximately 2.70% of the 111 places under the International Offering. These places have been allotted 3,000 Shares in total, representing approximately 0.005% of the 63,000,000 Offer Shares available under the International Offering (before exercise of the Over-allotment Option) and approximately 0.004% of the 73,500,000 Offer Shares available under the International Offering (assuming the Over-allotment Option is exercised in full).
- The Directors confirm that, to the best of their knowledge, information and belief, no Offer Shares placed by or through the Sole Global Coordinator, the Joint Bookrunners, the Joint Lead Managers, the Co-lead Manager or the Underwriters under the Global Offering have been placed with any core connected person (as defined in the Listing Rules) of the Company, or to any connected clients (as set out in paragraph 5(1) of the Appendix 6 to the Listing Rules (the “**Placing Guidelines**”)), or persons set out in paragraph 5(2) of the Placing Guidelines, whether in their own names or through nominees. The International Offering is in compliance with the Placing Guidelines.

- The Directors also confirm that, to the best of their knowledge, information and belief, (a) no placee will, individually, hold more than 10% of the enlarged issued share capital of the Company immediately following the Global Offering; (b) there will not be any new substantial shareholder (as defined in the Listing Rules) of the Company immediately after the Global Offering; (c) the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08(1)(a) of the Listing Rules; (d) the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; (e) there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules; and (f) none of the Sole Sponsor, the Sole Global Coordinator, the Joint Bookrunners, the Joint Lead Managers, the Co-lead Manager, the Underwriters or their respective affiliated companies (as defined in Appendix 6 to the Listing Rules) has been placed with any Offer Shares for its own benefit under the Global Offering.
- The Directors also confirm that, to the best of their knowledge, information and belief, (a) none of the Offer Shares subscribed by the placees or the public has been financed directly or indirectly by any of the Directors, chief executives of the Company, the Controlling Shareholders, substantial Shareholders, existing shareholders of the Company or any of its subsidiaries or their respective close associates; and (b) none of the placees or the public who has subscribed for the Offer Shares is accustomed to taking instructions from any of the Directors, chief executives of the Company, the Controlling Shareholders, substantial Shareholders, existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of the Shares registered in his/her/its name or otherwise held by him/her/it.

OVER-ALLOTMENT OPTION

In connection with the Global Offering, the Company has granted to the International Underwriters the Over-allotment Option, exercisable in whole or in part by the Sole Global Coordinator (for itself and on behalf of the other International Underwriters at their sole and absolute discretion), at any time within 30 days after the last day for lodging of applications under the Hong Kong Public Offering (the last day for exercise of the Over-allotment Option being Wednesday, August 4, 2021) to require the Company to allot and issue up to 10,500,000 additional Shares, representing 15% of the total number of Offer Shares initially available under the Global Offering, at the final Offer Price, to cover over-allocations in the International Offering, if any. There has been an over-allocation of 10,500,000 Shares in the International Offering and such over-allocation will be settled by using Shares to be borrowed under the Stock Borrowing Agreement between Yuelai Holding Limited and the Stabilizing Manager. The return of the borrowed Shares will be facilitated by exercising the Over-allotment Option or by making purchases in the secondary market or by a combination of these means. As of the date of this announcement, the Over-allotment Option has not been exercised.
